## TERMS AND CONDITIONS OF THE BID

#### 4. **Bid Scope**

- The Purchaser invites Proposals (hereinafter referred to as "the Bids") for 4.1 supply of Plant & Machinery, Hardware and I.T. Equipment (hereinafter referred to as "the Goods") and installation, configuration, deployment, testing, training and after-sale support of said Goods (hereinafter referred to as "the Services").
- The equipment will be delivered at the Office of the District & Sessions 4.2 Judge, Mansehra.

# Bid Eligibility/Qualification Criteria

- The bidders shall have registered/incorporated company/firm in Pakistan with relevant business experience of at least 3 years as on 20th February. 5.1 2025,
- must be registered with Tax Authorities as per prevailing latest tax rules (Only those companies which are validly registered with sales tax and 5.2

- income tax departments and having sound financial position and are active return filer, can participate);
- has valid Registration of General Sales Tax (GST) & National Tax 5.3 Number (NTN) and IBAN No.
- must be involved in sales or supply business of these items for at least 3 5.4 years,

If the Bidder agrees to extension of validity period of the Bid, the validity period of the Earnest Money shall also be suitably extended. The Bidder may refuse extension of validity period of the Bid, without forfeiting the Earnest Money.

### Modification/ Withdrawal of the Bid 13.

- The Bidder may, by written notice served on the Chairman, procurement Committee, modify or withdraw the Bid after submission 13.1 of the Bid, prior to the deadline for submission of the Bid.
- The Bid, withdrawn after the deadline for submission of the Bid and prior to the expiration of the period of the Bid validity, shall result in forfeiture 13.2 of the Bid Security.

#### Opening of the Bid 14.

All bidders scoring greater than or equal to 70% of the marks will be accepted in technical proposal, and their financial bids will be opened. The Bids which do not conform to the Technical Specifications or Bid conditions or the Bids from the Bidders without adequate capabilities for supply and maintenance / warranty services will be rejected. The Eligible/Technically Qualified Bidders will be considered for further evaluation. The Technical proposals shall be evaluated in the light of following evaluation criteria:

# 16. FINANCIAL PROPOSAL EVALUATION

- 16.1 Technically qualified/successful bidder(s) shall be informed telephonically for opening of the Financial Proposal(s). The Financial Proposals will be opened in the Conference Room, District and Sessions Court, Mansehra in the presence of the Bidders or their authorized representatives.
- 16.2 Financial Proposal evaluation will be conducted under the KP Public Procurement Rules, 2014. The Price evaluation will include all duties, taxes and expenses etc. In case of any exemption of duties and taxes made by the Government in favor of the Purchaser, the contractor shall be bound to adjust the same in the Financial Proposal.
- In cases of discrepancy between the cost/price quoted in Words and in Figures, the lower of the two will be considered.
- 16.4 In evaluation of the price of an imported item, the price will be determined and considered inclusive of the customs and other import duties etc.;
- In evaluation of the price of goods which arc subject to excise duty, sales tax, income tax or any other tax or duty levied by the Government, the price will be determined and considered inclusive of such duties and taxes.

- At first step, eligible bidder(s) as per clause-4 (Bid Eligibility) of this bid document fulfilling the qualification and technical evaluation criteria 18.1 will stand technically qualified.
- At second step, technically qualified and successful bidder(s) will be evaluated in the light of all Pre-Conditions, necessary requisites and shall 18.2 be selected on lowest cost quoted as per rules and fulfilling all coda! formalities, irrespective of their score in the previous step.

### 19.

Purchase Order to the successful Bidder will be issued after approval of the Competent Authority.

#### **Performance Security** 20.

- The successful Bidder/The Contractor shall furnish Performance Security within fourteen (14) days of the receipt of the Purchase Order, in the form of a Bank Guarantee or Banker Cheque, issued by a scheduled bank operating in Pakistan, as per the format provided in the Bid Document; for a sum equivalent to 10% of the contract value; denominated in Pak Rupees; have a minimum validity period until the date of expiry of warranty period, support period or termination of services, or fulfillment of all obligations under the contract, whichever is later. No other shape or form of performance security shall be acceptable with any validity less than the prescribed time period.
- The Performance Security shall be payable to the Office of the District & Sessions Judge, Mansehra, if the Contractor commits a default under 20.2 the Contract; fails to fulfill the obligations under the Contract or if violates any of the terms and conditions of the Contract.
- No interest on the amount of performance guaranty / Banker Cheque 20.3 shall be charged by Bidders.

### **Execution Schedule / Delivery** 21.

The Contractor shall deliver ordered Goods/ equipment within Fifteen Days from the issuance of Purchase Order. During project implementation and the warranty period; the Contractor shall provide maintenance, supply and procurement support necessary to maintain all system, at the contracted performance and reliability level. The Contractor shall arrange and pay for the transport of the Goods to the place of destination as specified in the Contract.

#### Liquidated Damages 22.

If the Contractor fails/ delays in supply/ performance of any of the obligations, under the Contract/ violates any of the provisions of the Contract

I commits breach of any of the terms and conditions of the Contract the Purchaser may, without prejudice to any other right of action/ remedy it may have, deduct from the Contract Price, as liquidated damages, a sum of money @I% of the total Contract Price which is attributable to such part of the Goods / the Services, in consequence of the failure / delay, be put to the intended use, for every day between the scheduled delivery date(s), with any extension of time thereof granted by the Purchaser, and the actual delivery date(s). Provided that the amount so deducted shall not exceed, in the aggregate, 20% of the Contract Price.

The Contractor shall arrange and undertake a comprehensive training program for the staff nominated by the Purchaser to ensure that they shall acquire a good working knowledge of the operation, and general maintenance of the Goods to be supplied under the Contract.

#### **Documentation** 24.

The Contractor shall furnish the user documentation, the operation manuals, and service manuals of the supplied Goods and other information pertaining to the performance of the Goods, in hard/ soft copy format, before the Goods are taken over by the Purchaser.
